Mr. Urban van aar, team leader, HaskoningDHV presented the concepts and key features of the project. This was followed by the question/answer session.

The key points discussed are as under.

- Representative from ITPI, Surat inquired about the basis of estimating the future population/density and broad land use for DREAM City.
- Representative form WTC suggested LIVE WORK PLAY concept with green amenities and leisure activity for the project and also inquired about the proposed urban form of the project and its phasing. They suggested considering the cluster formation for the other sunrise sectors or niche business as the focus of the project should not be limited to the anchor business (Diamond) they emphasised on the mix use development for DREAM City with lucrative financial incentives to attract the potential investors. To trigger the development, the iconic features should be developed.
- One of the participant suggested, Information Technology (IT) as one of the potential sectors to be developed in the DREAM City.
- One of the participant suggested that the development should be such that, It caters to the young talent from the city and the project should have space for skill development centers'.
- Representatives from Chamber of Commerce suggested incorporating the intelligent transportation system in DREAM City.
- One of the participants has an opinion of about preserving the heritage of the city by planning a museum building which reflects the history of old Surat city.
- One of the academicians inquired about the sector allocation in commercial zone. Tourism and hospitality should also be addressed with an emphasis on the identity of the city of Surat. She suggested that the consultant should also plan for alternatives in case the anchor industries fail. The end user profiling should be studied.
- A representative from SMC suggested that the city should be 24x7 live with an active night life. This will attract the potential investors in DREAM City. He also suggested the plan to be such that the Worker-Manager-Owner should live and work together. On the industry side, the spaces for godowns and showrooms should be planned within DREAM City.

Developers showed interest in the project and desired should be given incentives as "first mover advantage ".Residential development should be open for all targeting all sections of the society. Medical tourism/Educational hub//Convention centre's # Destination wedding venues/offices/ITES/NRI investments should also be taken in to consideration in the master plan. The proposed development should also connect to water and sea front which should act as a catalyst to the tourism industry.

- District Collector, Surat suggested the city should have educational institutions, IT development, Skill training centre for local industries, 24x7 recreational centre's and markets.
- Commissioner, SMC emphasised on NMT as sustainable mode of transportation in the DREAM City. He also suggested that river/creek should also be incorporated in the development.
- The workshop was concluded with the announcement about issuance of the Government notification regarding formation of a separate Urban Development Authority for the area of village Khajod included under the DREAM City project.
